1. Meeting Schedule

Sunday 23 rd November 2025 (0900)	International Bowling Federation Executive Committee Meeting
Sunday 23 rd November 2025 (1500)	International Bowling Federation General Meeting

Registration for the Meeting will commence one hour before the start of the Meeting at 1400 on 23rd November 2025.

2. Delegates participating in the International Bowling Federation General Meeting

A member federation may be represented at the International Bowling Federation General Meeting by a maximum of two delegates, only one of whom shall have voting rights. The names of the delegates must be submitted in writing to the International Bowling Federation stating the name of the member federation they represent and signed by an authorized officer of the member federation.

3. Proxies

A member federation which cannot be represented at the General Meeting may give its proxy to another federation. In all cases, the written proxy authority must be submitted on federation letterhead; signed by the President, Secretary General or CEO of the federation, and be sent to the International Bowling Federation. In the presence of the General Meeting all proxies will be validated before the proxy can be exercised. Such proxy must be submitted in writing to the International Bowling Federation by **the 9th November 2025**, stating the name of the country to which the vote is to be transferred and signed by an authorized officer of the federation.

Any Proxies received after 9th November 2025, will not be valid.

The proxy also must be on the **federation's letter head paper** or with the **federation's chop** and signed by an **authorized officer**.

4. Proposals for the Meeting

Only member federations, the Executive Board/Presidium of the International Bowling Federation geographic zones, and the International Bowling Federation Executive Committee may submit proposals to be acted upon by the General Meeting. Proposals shall be submitted to the International Bowling Federation **by 10th September 2025**.

5. Official Hotel

6. *Shuttles Service (Airport, Hotels, Bowling Centre and vice versa)*

All delegations of the championships and delegates to the Meetings staying in the Official Hotel will be met at the airport and a similar service will be provided upon departures.

7. *Meeting Fees*

The International Bowling Federation General Meeting Fee is \$200 USD for each delegate and includes

- Airport pick-up service upon arrival and upon departure if staying at the official hotel
- Coffee and tea facilities
- Refreshments
- Water station

Meeting fees can be **paid** by Cash upon arrival.

8. *Visa Information*

No visa for entry is required for more than 170 countries/regions. However, the visa-free period may vary among different countries/ regions. The entry forms are NOT valid as visas. All countries/ regions should confirm visa information independently by checking “Part II of Visit Visa/ Entry Permit Requirements for the Hong Kong Special Administrative Region” from the Immigration Department of the Government of the Hong Kong Special Administrative Region www.immd.gov.hk/eng/services/visas/visit-transit/visit-visa-entry-permit.html.

The application form could be found in www.immd.gov.hk/eng/forms/hk-visas/visit-transit.html. The application process may take more than 6 weeks’ time. All visa applications must be submitted to HKCTBC at least 2 months before the meeting to facilitate our processing with the HKSAR Immigration Department and NOT to the Chinese Embassy in your country/regions. We earnestly request that all filled out forms should be emailed to HKCTBC.

9. *Forms and deadlines*

Form A: International Bowling Federation General Meeting Form

The deadline for the form to be received is **10th September 2025**.

Hotel Form, including Arrival/Departure Information and Rooming List

The ultimate deadline for the form to be received is **30th September 2025**.

Reservation form must be submitted directly to the hotel with a copy to ceo@ibf-bowling.org

First night room charge guarantee of all the rooms reserved must be made before booking could be confirmed. The payment method of the guarantee is stated in the Official Hotel's form.

Deadline for reservation is September 30, 2025. Deadline for room cancellation is October 30, 2025. Forfeiture of the first night deposit of the booked rooms charges applied if cancellation is made after the deadline or for no show.

All bookings are on a first-come-first-serve basis, reservations made after the deadline will be subject to availability of rooms at the Official Hotel and room rates may not be the same.
